# GCU STEM CAMP BEHAVIOR CONTRACT

Please review the following contract with your student camper. Ensure that your camper understands the rules and will be required to follow these guidelines throughout the camp session from the time they arrive on the Grand Canyon University (GCU) campus until they leave. Failure to follow the guidelines may result in disciplinary action including expulsion from camp without a refund.

Both the camper and their parent/guardian must initial beside each guideline to demonstrate that the guideline is understood and that they agree to abide by the rules and policies of the GCU STEM Summer Camp.

**While at GCU STEM Camp, I will:**

- \_\_\_\_\_(camper initials)\_\_\_\_\_(parent/guardian initials) Demonstrate responsibility toward all GCU property including my dorm room, classroom spaces, campus shared spaces (recreational areas, dining areas, open spaces, etc.) and all equipment used. I understand that damage, defacement or loss will result in disciplinary action including possible monetary payment for lost or damaged items.

**While at GCU STEM Camp, I will NOT:**

- \_\_\_\_\_(camper initials)\_\_\_\_\_(parent/guardian initials) Bring any items onto the GCU campus which are unlawful or otherwise prohibited including but not limited to: tobacco (of any kind), drugs, alcohol, weapons (of any kind), fireworks or medication not included on the camper information sheet.
- \_\_\_\_\_(camper initials)\_\_\_\_\_(parent/guardian initials) Have guests of the opposite sex in my dorm room.
- \_\_\_\_\_(camper initials)\_\_\_\_\_(parent/guardian initials) Engage in any behavior which is sexually inappropriate, threatening or harassing.
